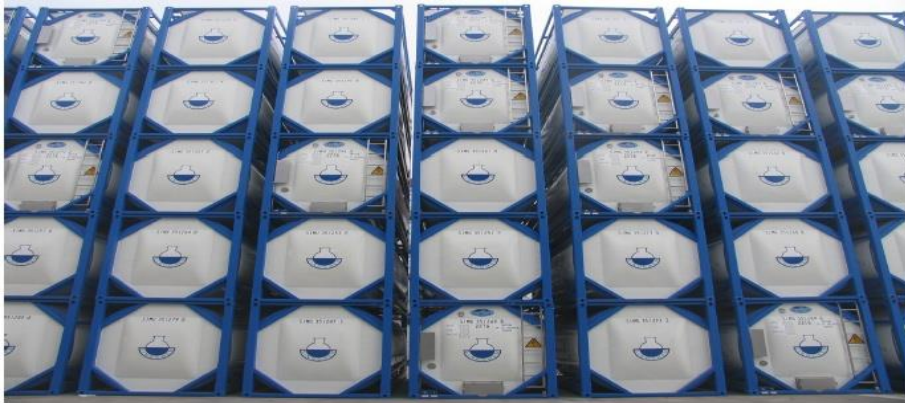



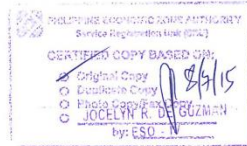

Dear Ms. Pantas:

This refers to your letter dated 03 August 2015 requesting for renewal of the authority for F2 Global Logistics, Inc. (F2-GLI) to provide air and sea freight forwarding services to PEZA-registered enterprises, which expired on 10 March 2015. Please note that your Provisional Authority should be renewed one week before expiry date; otherwise, a penalty of one percent (1%) of franchise fee shall be imposed per month of delay.

Considering that our PEZA Security Services has certified that your firm has no derogatory record since it was granted its first Provisional Authority on 05 March 2011, please be informed that your request is **APPROVED** and F2-GLI's authority is hereby renewed effective upon payment by F2-GLI to PEZA of the franchise fee of Php6,000.00 and submission of F2-GLI's updated Surety Bond, subject further to the following terms and conditions:

1. Prior to F2-GLI's first transaction with any PEZA-office/unit under this authority, F2-GLI shall **submit a true copy of this Authority**, certified by the PEZA - Office of the DDG - Operations / Service Registration Unit to a.) the Zone Administrator / Zone Manager of the PEZA Economic Zone where F2-GLI's PEZA-enterprise clients are located (two copies); (b) the Department Manager, Security Services Department; and (c) the Officer-in-Charge of the PEZA-Customs Documentation Units (PCDUs).
2. This authority shall **automatically be suspended**, in case of violation of any of the terms and conditions of this Authority or if any of F2-GLI's personnel are involved in diversion, pilferage, or hijacking of shipment of PEZA enterprises, and/or any other irregular/illegal activity, without prejudice to any further administrative sanctions which PEZA may take, in which case, the liability of any of F2-GLI's personnel shall extend to the company/principal.
3. Only the Licensed Customs Broker, Officers and official representatives / processors of F2-GLI shall be allowed to transact business for F2-GLI's PEZA operations in the capacities related to their positions.
4. F2-GLI shall submit to PEZA - Office of the DDG - Operations / Service Registration Unit the names of its new personnel and those who are no longer in their employ.

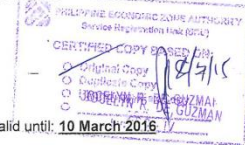
5. F2-GLI must notify PEZA - Office of the DDG - Operations / Service Registration Unit in writing of any change of address and contact details within 7 working days when the change is effected, otherwise F2-GLI's authority will be suspended (or cancelled) and F2-GLI will not be allowed to transact business with ecozone locators.
6. PEZA fees to be collected by F2-GLI from its PEZA-registered enterprise clients shall only be the amount authorized by PEZA and should be indicated as a separate item in its billings to said clients. Collection of fees in excess of those authorized by PEZA, or if such unauthorized fees are found to be included in the authorized PEZA fees, shall be cause for cancellation of this authority.
7. Renewal of this authority shall be subject to filing of the following with PEZA not later than **seven (7) days** prior to the expiry hereof: (a) letter-request for renewal of this Authority addressed to the Director General; (b) renewal of required government permits and licenses, if expired; (c) letter request for Certification stating that F2-GLI has "No Derogatory Record" addressed to the PEZA Security Services Department, tel. nos. 551-3426 / 44; (d) list of PEZA enterprise-clients; and, (e) copy of this Authority.
8. Should F2-GLI need to subcontract or hire the services of other freight forwarders, customs brokers, and/or truckers for its PEZA-enterprise clients, it shall engage the services only of PEZA-authorized service enterprises, in which case F2-GLI shall be held responsible for the actions of the said entity/ies.
9. Should F2-GLI need PEZA vehicle stickers for its PEZA operation, F2-GLI shall submit to PEZA - Service Registration Unit a notarized Affidavit signed by its highest responsible official, stating that the company shall be responsible / accountable for the conduct of their drivers and helpers; that their vehicles are road worthy / in good running condition; shall exclusively be used for its PEZA clients and shall not be for hire.
10. F2-GLI's government permits and licenses for Years 2015 and 2016, including those for its personnel, as well as the fidelity or surety bond required by PEZA, **must be updated and valid at all times.**

All other terms and conditions in F2-GLI's original Provisional Authority dated 05 March 2011 and in succeeding authorities issued thereafter shall remain in force.


