## **Coronavirus Disease 2019**

As the threat of the coronavirus is not slowing down, starting February Health Team of the SHE Committee are implementing the Health Declaration as part of the preventive measure for the 2019 Novela Coronavirus (2019 - Ncov), now known as Coronavirus Disease 2019 (Covid-19). Employees are required to answer honestly the health declaration for in google form sent by the HR department in the email. For those who will answer that they have a recent travel history in a country that has substantial quantity of Ncov case and has symptom are going to be advised to do self quarantine in their homes, while to those have fever and other symptoms they will have to wear mask when they are in the facility and they will be closely monitored by the Health Team of SHE Committee.



To further improve the awareness of F2 employees on the corona virus, SHE Committee coordinated with the Local Health Center of Barangay of San Dionisio and invited last Feb. 14, 2020, Dr. Ma. Dolores Matias, the Medical Officer V of San Dionisio Health Center, and Kagawad Majel Co, to talk on the recent situations in the Philippines and in other countries regarding the corona virus and the action plans of the local government and barangay in the issue.





SHE Committee will continue to closely monitor the epidemic and will continue to gather information and to implement precautionary measures to fight back on the threats of this virus for the safety and health of the F2 Organization.







#### F2 Annual Fire Safety Seminar and Drill 2020

Further, to ensure F2 Organization is prepared in all emergencies, last February 17, 2020, at 6:00 pm, Annual Fire Seminar and Drill was conducted. Because fire emergency can happen in any time of the day, this fire drill is conducted during the night time to cover the employees in the night shift and employees that extends their work in the night. This is to equip them with the awareness and knowledge in time of emergency like fire. It was attended by both F2 Logistics Philippines, Inc. and F2 Global Logistics, Inc. employees, with a total of 112 attendees.




For the first time for F2 Organization, different scenarios were set by the BCP's Emergency Response Team. There were employees acting as a pregnant, person with disability and with injuries cause by the fire. Emergency Response Team and the First Aid Team have done their duties and responsibilities as if there was really an actual emergency. The evacuation of all employees was only 3 minutes and 46 seconds, a good number considering all locations in F2 Corporate Center were involved in the drill.



Objective of this training is to enhance workplace health, safety and work design. Hence, F2 employees can enhance performance and productivity and prevent fatigue or injury.












# **Safety Data Monitoring**

- 1) Days without Lost Time Accident refers to total safe man days for all employees both F2 Logistics and F2 Global without reported lost time accident. It will return to zero when a lost time accident occurs.
- 2) Safe Man Hours YTD total man hours per month from January 2020 to date
- 3) Accumulated Safe Man Hours- total safe man hours for all employees both F2 Logistics and F2 Global without reported lost time accident since the start of the program in January 2019 to date. It will return to zero when a lost time accident occurs.
